### Office Memorandum

Subject: Ensuring participation of all Medical Institutions in the NTF Survey launched under the directions of the Hon'ble Supreme Court of India-reg,

The undersigned is directed to state that a Circular dated 04.09.2025 was received from PN-II Section, Department of Higher Education, informing that the National Task Force (NTF) constituted by the Hon'ble Supreme Court of India has launched a series of surveys on its official website (https://nrf.education.gov.in/) to gather crucial inputs from various stakeholders, including students, parents, faculty members, mental health service providers and institutional representatives.

- 2. It was further informed that the Chairperson of the NTF has addressed letters to all heads of Higher Education Institutions with instructions to ensure timely completion of the survey. A communication regarding this from this Division dated 09.09.2025 was also forwarded to ME Division for necessary action.
- 3. However, during the Hon'ble Supreme Court hearing dated 10.10.2025, (copy enclosed) it was observed with concern that nearly 57,000 institutions have not responded to the ongoing survey. The Court expressed strong displeasure over the lack of cooperation and directed the Union of India to take the matter up with all non-responsive institutions and ensure full compliance.
- 4. In view of the above, the ME Division is requested to take up the matter with the National Medical Commission (NMC), National Dental Commission (NDC), National Nursing Council and National Council for Allied Health Professionals, and direct the Institutions registered under respective bodies to mandatorily respond to the NTF survey without any further delay. Further, Medical Institutes may be directed to widely disseminate information regarding the surveys among students, parents, and faculty members, and to actively encourage participation to facilitate accurate and comprehensive data collection. The procedure for responding to the survey is stated in the correspondences enclosed.

It may be noted that non-compliance at this stage may attract adverse observations 5. from the Hon'ble Supreme Court, and hence, the matter warrants urgent attention and strict compliance
