<u>Sub: Extension of Last date of Admission for the ANM, GNM and B.Sc.(N) Programs</u> for Academic year 2025-26- reg.

In continuation to earlier notification no. 10 of 2025 dated 17.09.2025, Indian Nursing Council has considered the request from the States with respect to extension of last date of admission for ANM, GNM and B.Sc.(N), programs for the Academic Year 2025-26 till **30**th **November 2025**.

The total number of students admitted upto 31st Oct 2025 (regular batch) and 30th Nov 2025 (irregular batch) should add up to the sanctioned strength and shall not exceed the Annual intake.

NOTE:

It shall be ensured that the INC guidelines with respect to completion of syllabus in various nursing programs be strictly followed.

- a) For B.Sc.(N)- The Universities/ Colleges of Nursing shall implement the B.Sc.(N) program semester wise. In this context, it is clarified that the students who are admitted upto 31st Oct 2025 shall be considered as REGULAR BATCH. The students admitted from 1st Nov 2025 onwards will be considered as IRREGULAR BATCH. Examination shall be conducted separately for the above batches. Universities shall ensure that institution shall comply with semester requirements as prescribed in the revised BSc(N) syllabus before the conduct of examination:
- b) For GNM & ANM- Eligibility for annual examinations to be strictly adhered to as per prescribed syllabi.
- c) No request for further extension shall be considered. No admission after the cutoff date i.e. 30th Nov 2025 will be undertaken.

No deviation in the admission criteria shall be accepted by State Examination Board/Council/ University as per the WP no. 5697 order. Strict action to be initiated by State Examination Board/Council/University against institution/management in case of non adherence to admission terms & conditions prescribed by INC for various nursing programs.
